Applications in prescribed form are invited from citizens of India for filling up of 19 (nineteen) posts of Assistant Professor for the Govt. Law College of Arunachal Pradesh in the pay band-3 of Rs. 15600-39100 with AGP of Rs. 6000/- per month plus other allowances as admissible to Arunachal Pradesh Govt. Employees from time to time. Vacancy position is subject to variation.

2. <u>AGE:-</u>

(i) Candidates appearing for post of Assistant Professor must not be above 30 years of age as on **31.01.2018**. However, the upper age limit is relaxable in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time.

3. EDUCATIONAL QUALIFICATION:-

- (I) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level (LL.M. & English) from an Indian University, or an equivalent degree from an accredited foreign university. However, there is a relaxation of 5% marks that is from 55% to 50% marks at Masters Degree level for the ST/SC candidates.
- (ii) The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Candidates, who are, or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET or recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.
- 4. <u>METHOD OF SELECTION</u>: The eligible candidates will have to appear in an Interview/Viva-Voce test to be conducted by the Commission at Itanagar or any other place, which may be decided by the Commission. The final selection of the candidates will be made on the basis of the candidate's performance in the Interview/Viva-voce purely on merit.

NOTE: COMMISSION WILL ADOPT RECRUITMENT TEST(OBJECTIVE TYPE)OR ANY OTHER MEANS INCLUDING ACADEMIC PERFORMANCE TO SHORTLIST NO. OF CANDIDATES BEFORE THE INTERVIEW/VIVA-VOCE, IF IT IS DEEMED NECESSARY TO DO SO.
