NOTE:- For recruitment in Pay Matrix Level 2nd (7th CPC) achievements should be in the current and/or immediate, preceding 02 years i.e. from 01.04.15 and the sports person should be an active player. For validity of sports achievement, concluding day of the championship/event shall be taken into account.

IV) (a) APPLICATION FEE :-

(i) For all candidates except those mentioned in sub-Para (ii) below Rs. 500/- (Rs. Five Hundred only)

(ii) For candidates belonging to SC/ST/Ex-Servicemen/Persons with Disability/Women/Minorities* and Economic Backward Class** Rs. 250/- (Rs. Two Hundred Fifty Only) with a provision for refunding the same to those who are found eligible as per notification and actually appear in the Selection Trials. Candidates in this category should check their eligibility thoroughly before applying. Fee in respect of candidates who are ineligible, but still apply shall not be refunded.

(b) FEE EXEMPTIONS:- A) For claiming exemption/refund from the application fee, Minority candidates should submit 'self declaration' as mentioned in Format 'A' at the time of Document Verification. ***Minorities mean Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis).** Such candidates claiming exemption of application fee will be required to furnish 'minority community declaration' affidavit on non-judicial stamp paper that he/she belongs to any of the above minority community. If the affidavit is not produced during document verification, the candidature will be rejected. B)**Economically Backward Classes (EBC) will mean the candidates whose Family Income is less than Rs. 50,000/- Per Annum. The following authorities are authorized to issue income certificate for the purpose of identifying Economically Backward Classes (EBC): (i) District Magistrate or any other Revenue Officer up to the level of Tehsildar. (ii) Sitting Member of Parliament of Lok Sabha for persons of their own constituency. (iii) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways. (iv) Union Minister may also recommend for any persons from anywhere in the country. (v) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside. Railway Administration reserve the right to cancel the Recruitment process in exceptional circumstances. 10. Under no circumstances applications received after the closing date & time will be entertained. 11. The sports persons appointed against Sports Quota through Open Advertisement will undergo probation periods of two years after completion of training, if any. 12. The sports persons recruited against Sports Quota through Open Advertisement will have to fill and sign the Service Bond for a period of five years. 13. The sports persons appointed through Open Advertisement Quota, shall fulfill the minimum medical norms for the post, for which they will be appointed. 14. Sports persons recruited against sports quota through open advertisement shall be terminated from service, if the information and documents furnished by them for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination. 15. Applicant should mention his/her playing position alongwith the game in the application form. 16. Candidate those who are already in service of PSU/Government Organizations and are eligible for the above, should produce "No Objection Certificate" for the same from their employer at the time of applying/trials. 17. Candidate's admission at all stages of the recruitment will be purely Provisional subject to satisfying the prescribed eligibility conditions. Merit issue of call letters to the candidate will not imply that his candidature has been finally cleared. 18. Sports persons having sports norms for higher level and apply against the vacancies for the lower level, can be considered. However, he/she will not claim for higher level after joining the Railways on the basis of sports achievements prior to joining Railways. 19. The decision of selection committee/administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection. 20. Production of original documents of Date of birth, Educational Qualification, Sports Achievement and SC/ST/OBC etc on the day of Trial and Interview is mandatory without which they will not be allowed to appear in the Trial/Interview.
